



## MINUTES

### SPECIAL MEETING OF THE KENDRICK CITY COUNCIL

THURSDAY January. 26<sup>th</sup>, 2022,

Kendrick Idaho

The meeting was held at the Kendrick Fire Hall at 8:00 AM. The Pledge was said, and the meeting was called to order at 8:00 AM.

#### **1) Agenda:**

##### A. Consideration of additional hours for Kori Claffey (Action Item)

The council asked the Nadine Towne city clerk several questions concerning the audit and how soon it would be completed. The City Clerk answered all questions and explained that help was still needed to get all the paperwork together for the audit. Council member Jesse Wegner made a motion to approve an additional 12 hours for \$300. 00 for Kori Claffey with an updated report from Nadine Towne the City Clerk. ##### B. Sewer Line North 9<sup>th</sup> Street report/cost (Action Item)

This sewer line serves 10 -15 homes on the upper half of 9<sup>th</sup> (schoolhouse hill) including the 6 or so homes in the general area of 124 N. 9<sup>th</sup> St. It is approximately



300 ft of pipe in the city right of way that has deteriorated and is in need of immediate repair. There is funding left over from a prior project in the city. Jake Lustig the city maintenance supervisor is looking into the amount and how the funding is available. Jake is running the camera down the line to see just how bad it is. This will be a rather large project and the city will need to hire out for this project to be completed.
