1) Consent Agenda:

A. Minutes: Approve March 21st, 2023, minutes (Action Item)

Council member Keith Wilson made a motion to accept the minutes from March 21st, 2023. Council member Jesse Wegner seconded the motion, all in favor, motion carried.

B. Disbursements: \$13,071.79 (Action Item)

Council member Jesse Wegner made a motion to approve the disbursements in the amount of \$13071.79. Council member Keith Wilson seconded the motion, all in favor, motion carried.

C. Approval of 2019-2020 Audit with Jordan Zwygart, (Zwygart John & Associates CPAs, PLLC) \$12,000 (Action Item)

D. Hiring of Lifeguards, Office Clerk/Swim Team Chelsey Ball, & Part Time Employee Ralli Roetcisoender, (Lifeguard) (Action Item) Mayor Rose explained that last

month we forgot to add the hiring of Ralli Roetcisoender as summer help. Xavier Carpenter will be a returning lifeguard. Keegan Anderson, Mercedes Heimgartner, Mason Kimberling and Carson Hogan will all be joining as lifeguards.

2) Unfinished Business:

A. Moose Draw status (Action Item)

The Moose Draw Association has paid for the 1st 10 loads of wastewater. There seems to have been miscommunication between Idaho Rural Water Association, Kings Throne and the Moose Draw Association, they only had a budget enough for 10 loads of wastewater. Kings Throne had hauled in another 6 loads before they were asked to stop hauling. Nadine Towne the City Clerk has billed Moose Draw for the additional 6 loads and is waiting for payment.

B. Redesignation of Council Member for Wells Fargo Authorized Financial Accounts (Action Item)

Council member Jesse Wegner was nominated by the mayor to be the additional financial signer for the Wells Fargo accounts to meet the financial control policy. Council member Keith Wilson made a motion to add Jesse Wegner as the additional signer to the Wells Fargo accounts. Council member Paul Rush seconded the motion, all in favor, motion carried.

C. Computer Doctors Malware Protection (Action Item)

Nadine Towne the City Clerk explained what it is that the Computer Doctor does for the city's computers for protection. The council agrees that it is a good expense for the city's computers to have the protection and backup service that the computer Doctor provides the city. The monthly cost for the virus protection and the backup for the 3 office computers would be \$120.00 per month. Council member

C. Resolution 17-008 Repealing Previous Code Fees and Adopting an Updated Fee Schedule Latah County Inspection Services for the City of Kendrick. (Action Item)

Mayor Rose read Resolution 17-008 in its entirety. The city will receive 20% of the building fees collected by Latah County. Council member Jesse Wegner made a

E. Resolution 17-009 for Providing for a Change in Swimming Pool Rates (Action Item)


