A. Autumn & Nick Mc Pherson request for 3 Months in RV (Action Item)

Autumn called city hall this am 2/20/24 to say that they will no longer be living in their RV. They have moved into their house.

B. Fire Chief Val Norris Fire Department Update & Plans (Action Item)

Fire Chief Val Norris gave an update as to all that the Fire Department has been doing in the last few months. The fire department will be taking the Fire Fighter 1 Class. The Water tender will be getting new boxes (funds from truck fund). There are racks that need to be put up at the fire hall. The fire department is behind on the PPE's and the SCBA (breathing apparatus) are becoming outdated. The cost to outfit a firefighter is a lot (\$3000.00) Deary Fire Department is sharing their "old" equipment and that is helping with the burden of trying to purchase new equipment. The trucks need some updated parts as well to stay in compliance with the ISO rating. The ISO rating is a very important part of the insurance for the city residents and Fire Department. Council member Susan Alexander asked how the Fire Dept. gets their funds. Chief Norris explained that the budget is derived from taxes collected for Fire protection and they used to do the turkey raffle but that the car wash is the best fundraiser for the Fire Dept. Chief Norris also has been able to use the water tender for IDL during fire season and the department has been paid for that service. All monies are in a truck fund.
