Call to Order Special Meeting of September 24th, 2024 /Pledge of Allegiance

PUBLIC HEARINGS

Mayor Norris opened the Hearing at 8:00 am There was no public present. Present were: Councilmembers Wegner, Seegmiller, Alexander and Mayor Norris.

- A. Consideration and Decision of a Request for a Variance on the 3rd Street Side Setback of 301 E. Main Street in Kendrick described as Block 6, W ½ of Lot 4 Plus Lots 5 & 6. The Purpose Would Be to Build a Shop/Garage. Kendrick Juliaetta Planning & Zoning Commission held a Public Hearing on Monday, September 16, 2024, and is Recommending Approval with the stipulation of one story only on the shop. Consideration and Approval of Ordinance No. 802: An Ordinance Entitled the Annual Appropriations Ordinance for the Fiscal Year Beginning October 1, 2024, Appropriating the Sum of \$4,243,938 to Defray the Expenses and Liabilities of the City of Kendrick for Said Fiscal Year, authorizing a Levy of a Sufficient Tax Upon the Taxable Property and Specifying the Objects and Purpose For Which Said Appropriation is Made. Motion ready by title and dispensed with the reading three times. Motion by Councilmember Wegner to dispense with the reading three times and read once in full. Councilmember Seegmiller seconded the motion. All in favor.
- **D.** Consideration and Approval of Health, Vision and Dental Insurance Benefits from American Insurance for City Employees. Motion to approve the American Insurance quote for the city employees by Councilmember Wegner and seconded by Councilmember Alexander. All in favor.
